PEOPLES COMMUNITY CREDIT UNION NOMINATING COMMITTEE SEEKS CANDIDATES FOR ELECTION TO BOARD OF DIRECTORS & SUPERVISORY COMMITTEE.

The Nominating Committee of PEOPLES Community Credit Union is seeking members who want to make a difference in their credit union by serving on either the Board of Directors or the Supervisory Committee.

We will select nominees who demonstrate, to the satisfaction of the Committee, good character, fiscal responsibility, a commitment to serve as a volunteer in the best interests of their fellow credit union members and the willingness and ability to fulfill the responsibilities of the position.

Nominees must be members in good standing with the credit union for at least two years, not be employed by the credit union and be bondable. The Committee will determine a candidate's suitability for nomination by reviewing the information submitted, the candidate's credit report, credit union account history and by interviewing the candidate.

Among the commitments one makes by accepting a position as a member of the Board of Directors or the Supervisory Committee are the following:

- Attend and actively participate in all regular meetings of the Board/Supervisory Committee.*
- Attend the credit union's Annual Meeting.*
- Acquire and maintain the knowledge and skills necessary to perform the duties of a Board/Supervisory Committee member by participating in appropriate credit union-related training opportunities.*
- Maintain confidentiality of discussions in meetings and all matters pertaining to the credit union that is not public knowledge.*

Interested members must submit their letter of interest and resume no later than July 31, 2011 for consideration. Please mail to the credit union, ATTN: Nominating Committee, or email to generalinfo@peoplesccu.coop.

The Nominating Committee will review each application and conduct personal interviews. Each nominee will be advised in writing of the Committee decision.

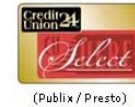
